Sub: Settlement of unsettled / withheld subsidy claims.

Kindly refer to this office letter No 1-1/2008-USF dt. 29.10.08, communicating therewith the status of unsettled and withheld claims upto QE. 30.06.08, with the request to ensure settlement of pending claims by 15.11.08. It was also requested to observe the prescribed time schedule for the settlement of the claims for QE. Sept.08.

- 2. In this connection also kindly refer to the instructions issued in the recent past vide following letters, reiterating the provisions regarding settlement of subsidy claims:
  - i. <u>Letter No.1-1/2008-USF(Payments)/206-230 dated 17.04.08.</u> It has been clearly stated in para 7 of the letter ibid that as per financial conditions of the agreement claims should be settled within 30 days of its receipt. It has also been stated in the letter that the cases of non-settlement of claims within a month's time should be intimated to Administrator, USOF along with the reasons for non-settlement.
- ii. Letter No.1-1/2008-USF(Corr)/498-522 dated 22.5.08, interalia communicating the adverse comments made by Parliamentary Standing Committee on IT, over unsettled subsidy claims. It was, therefore, emphasized that the unsettled/withheld claims as on 1.4.08 be finally settled by 30-6-08. It was also requested to complete the verification process (if not, already completed) in respect of RDEL-A claims for Q.E. 31-3-07 and to furnish a status report communicating the closing balance of number of RDELs as on 31-3-07 by 15-7-2008.
- Letter No.30-15/2004-USF/526-555 dated 23.5.08 requesting for complete verification of VPTs with reference to Subscriber Record Cord (SRC) and to furnish status report by 30-9-08
- iv. <u>Letter No.1-1/2008-USF (Corr)/749-768 dated 27-6-08</u> requesting to finally settle the old pending/withheld claims by 30-9-08.

- Joint Administrator (F) DO Letter No.1-1/2008-USF/956-986 dated 10.8.08
  reiterating the need for observance of prescribed time schedule for settlement of
  claims.
- 3. It is ,however, observed from the status of unsettled/withheld claims upto Q.E. June 08 as on 18.12.08 that the claims as per details given below are still lying unsettled.
